1. What Are Cookies?

Cookies are small text files that are placed on your device when you visit a website. They are widely used to make websites work more efficiently, as well as to provide information to the website owner. Cookies can store a variety of information, such as your preferences, browsing habits, or whether you are logged into an account.

2. Types of Cookies We Use

We use the following types of cookies on the Site:

- Analytical/Performance Cookies: These cookies collect information about how visitors

 users interact with it.
- **Functionality Cookies:** These cookies allow the Site to remember your preferences and choices, such as language selection or region, to provide a more personalised experience.
- Targeting/Advertising Cookies: These cookies are used to deliver adverts more relevant to you and your interests. They are also used to limit the number of times you see an advertisement and to help measure the effectiveness of advertising campaigns.

3. Why We Use Cookies

We use cookies for the following reasons:

- To enhance your experience and customise your preferences.
- To analyse Site traffic and improve functionality.
- To track the effectiveness of our marketing efforts.
- To ensure that the Site operates efficiently and securely.

4. Managing Cookies

- Browser Settings: Most web browsers automatically accept cookies, but you can adjust
 your browser settings to refuse cookies or to alert you when a cookie is being placed on
 your device. The help section of your browser should provide instructions on how to do
 this. Please note that if you block or delete cookies, some parts of the Site may not
 function as intended.
- Cookie Consent Tool: When you first visit the Site, you will be prompted with a cookie banner to accept or manage cookies. You can change your preferences at any time by accessing the cookie settings through the banner or through your browser settings.

5. Third-Party Cookies

We may allow third parties, such as advertising networks and analytics providers, to place cookies on your device when you visit the Site. These third parties may use cookies to collect information about your browsing activities across different websites to provide tailored advertising and/or analyse Site usage.

6. Retaining Cookies

Cookies may remain on your device for varying lengths of time. Some cookies are "session cookies", which are deleted once you close your browser, while others are "persistent cookies", which remain on your device until they expire or are manually deleted. You can adjust your browser settings to delete cookies when you close your browser or to manage the lifespan of persistent cookies.
